

MINUTES OF THE SPECIAL MEETING OF THE BOARD OF EDUCATION OF CREVE COEUR SCHOOL DISTRICT NO. 76, HELD AT LITCHFIELD BUILDING, 400 N. HIGHLAND AVENUE, CREVE COEUR, ILLINOIS, ON MARCH 1, 2011

President Bailey called the meeting to order at 6:30 p.m. Answering roll call were Cheri Archdale, Devin Boles, Michele Franklin, Valerie Ragon, Pam Greiner and Linda Bailey. Absent was Chuck Thomas. Also present was Administrator Mr. Brad Bennett.

Pledge of Allegiance.

Mrs. Ragon, seconded by Mrs. Franklin, made the motion to enter into executive session for disciplinary/expulsion hearing at 6:32 p.m. ROLL CALL VOTE-Yeas were Archdale, Boles, Franklin, Ragon, Greiner and Bailey. Nays were none. Motion carried.

Mrs. Ragon, seconded by Mrs. Archdale, made the motion to resume regular session at 6:55 p.m. ROLL CALL VOTE-Yeas were Archdale, Boles, Franklin, Ragon, Greiner and Bailey. Nays were none. Motion carried.

Mrs. Greiner, seconded by Mrs. Ragon, made the motion that the Board of Education of Creve Coeur School District No. 76 finds that Student No. 11-01 was guilty of gross misconduct, as set forth in the Illinois School Code and in violation of School Board policies; it is further determined that Student No. 11-01 be and is hereby expelled from Creve Coeur School District No. 76, for the remainder of the 2010-2011 school year. ROLL CALL VOTE-Yeas were Archdale, Boles, Franklin, Ragon, Greiner and Bailey. Nays were none. Motion carried.

Mrs. Greiner, seconded by Mrs. Archdale, made the motion that the expulsion of Student No. 11-01 be held in abeyance to allow Student No. 11-01 to return to school on March 2, 2011 on a probationary status for the remainder of the 2010-2011 school year, any suspendable offense shall require the student to appear before the Board of Education for review of the suspension. ROLL CALL VOTE-Yeas were Archdale, Boles, Franklin, Ragon, Greiner and Bailey. Nays were none. Motion carried.

Mrs. Ragon, seconded by Mrs. Archdale, made the motion to enter into executive session for discussion of appointment, employment, performance, termination of personnel and student matters at 7:00 p.m. ROLL CALL VOTE-Yeas were Archdale, Boles, Franklin, Ragon, Greiner and Bailey. Nays were none. Motion carried.
